Director's Report

Skate Park

Althoff said all work on the middle section has been completed. He is very happy with the way it turned out. Efforts are ongoing to raise money to upgrade the side ramps.

Baseball/Softball Leagues

All of the ball leagues will end in two weeks. Some baseball diamonds need to be touched up. Prices will be obtained for turfing two baseball fields. Althoff said the absence of rain is aiding in getting many jobs done but some watering is needed.

Dog Park

Pavers have been added at dog park entrances including many paid for by community members. Both parks have doggy drinking fountains now plus some picnic tables.

Althoff said one tennis court at Community Park needs to be resurfaced.

Playgrounds are planned to be renovated, particularly the one near the brown pavilion at Community Park.

Kluthe Pool

Althoff said plans are being considered to either revamp the pool or build a splash pad. He will meet again with representatives of Spear Corporation for prices. One benefit to a splash pad is that no lifeguards would be needed. He thinks having a splash pad that includes big zero depth slides would attract a lot of people.

Althoff reported that he has been contacted by a representative of Trophy Fitness from Texas, a company that manages fitness centers. The company is currently expanding their business into Minnesota and Tennessee. Althoff will reach out to them and schedule a presentation for sometime in September or October.

Althoff scheduled a special board meeting for July 17 at 6:15 pm for board members to pass the Budget/Appropriation Ordinance which has been on file for 30 days prior to passage,

Sehy said he has heard from the Latta family that their handicapped son really enjoys the special needs baseball games at Community Park. Staff can always be found to help with games. The games have many fans.
