Secretary's Report

A motion to accept the secretary's report was made by Palmer; second Cunningham; all ayes.

Treasurer's Report

Treasurer, Anita Broom, reviewed fund income statements for the month of October, 2023. Corporate fund total revenue was \$387,997.43 of which \$356,126.10 was from property taxes. Expenses for October were \$32,067.09 resulting in a net income of \$355,930.34. Year to date net income was \$166,975.27 which is right in line with last year's income at this time.

Recreation fund total revenue for October was \$292,641.47 of which \$284,921.29 was from property taxes. Net income for October was \$263,350.64 which is significantly higher than in October last year. Pool fund net income for the month of October was a negative \$13,354.52.

224 Passage of Bond Ordinance #313

The Board previously approved an interest rate of 4.25% from Washington Savings Bank. The \$750,000.00 plus interest will be paid back by December 1, 2024. About \$440,000.00 of the money will be used to cover debt certificate fees related to the Workman Sports Complex. This will be year 9 of a 15 year pay off schedule for the complex. The original loan was \$6 million. The remainder will be used for improvements to the skate park, replacement of the playground at Evergreen Hollow Park, and other park facility improvements and costs.

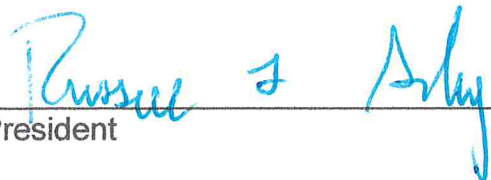
