In the absence of treasurer, Anita Broom, Althoff presented the treasurer's report. He noted that April is the last month of the district's fiscal year. He reviewed fund income statements for the month of December, 2023. Corporate fund net income was a negative \$54,199.98. Recreation fund total revenue for December was \$12,878.74 of which \$9,603.00 was for facility usage and program fees. Year to date income is significantly higher than at this time last year. Pool fund net income year to date is a negative \$69,352.26.

Director's Report

Althoff said the draft for the Girls Prep League will be held tonight. Khoury League draft has been held. Draft times for other leagues are scheduled. Registrations for soccer leagues are higher than last year but registrations for other leagues are lower.

Althoff said 25 lifeguards are needed for the summer season. Flyers have been sent to area schools advertising the openings.

The big Evergreen Hollow Park sign at the corner of Evergreen and Maple Street has blown down. Athoff distributed information and a picture received from Double D Signs, Inc. of an electronic message board that could be installed at that location. The sign can be programmed to advertise programs, activities, ball games, and events at the park and at the sports complex. The HSHS St. Anthony Physical Rehabilitation and Wellness business in the sports complex could also display information for which they would pay their share of the cost.

The information provided listed the cost of one 102 inch x 116 inch Internally lit Sign Cabinet for \$16,500.00, and one Electronic Message Center for \$21,120.00. Total cost of the project would be \$37,620.00.

Audit Report – Doehring, Winders & Co.

Matt Cekander, CPA, presented and discussed a draft of the Independent Auditor's Report of the financial statements of the Effingham Park District for the year ended April 30, 2022. General fund balance at the beginning of the year was \$2,221,789.00. Fund balance, end of the year, was \$2,580,923.00. Total net position at the end of the 2022 fiscal year was \$22,132,029.00 compared with \$21,153,448.00 at the end of fiscal year 2021.

Dasenbrock said he would like to see information from an architect for a revamped city pool, outdoor lazy river, and charges for a splash pad.
