Effingham Park Board Meeting

The regular meeting of the Effingham Park Board was held on Wednesday, September 4, 2024, at 5:30 pm at the Ron Diehl Center at 1906 South Fourth Street.

Secretary's Report

A motion to accept the secretary's report was made by Palmer; second Cunningham, all ayes.

Treasurer's Report

Treasurer, Anita Broom, reviewed fund income statements for the two months ending June 30, 2024. Corporate fund total revenue for June was \$90.47. Expenses for June were \$113,119.97 which included \$50,000.00 transferred from other funds through the corporate fund to the Workman Sports Complex. Net income for June was a negative \$113,029.50.

Recreation fund total revenue for June was \$50,406.23 of which \$34,843.50 was from program fees. This is \$9,596.75 more than was received in June last year in program fees and \$28,099.75 more year to date than in 2023. This is good. Expenses were \$98,269.02. Net income for June was a negative \$47,862.79. Year to date income is significantly better than at this time last year.

Pool fund total revenue for June was \$30,462.98 of which \$22,399.00 was for pool admissions. Total expenses were \$31,204.82. leaving a net income of a negative \$741.84. Year to date revenue was temporarily in the black at the end of June.

Passage of Ordinance 315 – Ascertaining the Prevailing Rate of Wages

Althoff reviewed the Illinois Department of Labor Wage Report.

A motion to adopt the Illinois Department of Labor Wage Rates for Effingham County as Ordinance 315 was made by Sehy; second Kronewitter; Four ayes/No nays.

Trophy Fitness Recommended Upgrades for Workman Sports Complex

Jarett Nobles, of Trophy Fitness, has been on site since the management contract with their agency began July 1, 2024, meeting with staff and studying current operations and equipment to determine ways to improve all aspects of the facility in order to increase membership and revenue. Trophy fitness will take official control of operations of the Workman Sports Complex September 17 when the contract with Rink Management ends.

Board members reviewed the Improvement Plan submitted by Trophy Fitness. They focused on two recommended areas of improvement that could be started now; the purchase of new Fitness Equipment and Recovery Tools. A proposal is to remove half of the desk area upstairs to make way for a turf floor where recovery tools could be used by trainers. The tools would be locked up and only for trainer's use.

The following Recovery Tools were listed with estimated cost.
