A motion to accept the treasurer's report and pay the bills was made by Dasenbrock; second Cunningham; Four ayes/No nays.

#### **Public Comments**

Kim Koester and Brian Sehy, representing Effingham pickleball players, spoke to Board members about current and future pickleball courts. They thanked the park district for

installing the eight courts over the tennis courts at Hendelmeyer Park, and said they especially appreciate the addition of the eight "beautiful" permanent nets with wheels which make the courts professional enough to hold tournaments. Two very successful tournaments were held last year which brought participants from a wide range of areas.

Koester noted that summer leagues last year were full with not enough room for all those wanting to play. The three courts at the Workman Complex are always busy in the mornings with more people waiting. She said pickleball has become a big sport in Effingham and more courts are needed. The players would like to encourage the park district to create courts in the gymnasium at the Ron Diehl Center.

Althoff said three courts could be set up in the gym by first using tape to line the courts. The lines could be painted sometime later which would require closing the gym for about a week. He said mornings would be better for pickleball play because evenings are busy with volleyball and basketball games, etc. He said courts can be made available from 8:00 am – 2:00 pm Monday through Friday. Koester said they are looking at November, December, January, February and March as the most needed time for indoor play. It was mentioned that some permanent nets with wheels could be purchased for a discounted price of \$1,800.00 each. All agreed these would be needed. The old temporary nets would be hard to put up and take down while the permanent nets can easily be moved.

Althoff said there would be no charge to play for members of the Workman Sports Complex. A fee will need to be charged for others. He said there are more details to be worked out but work can begin to add three pickleball courts to the gymnasium.
